Re: Response to request from the Pennsylvania Association for Justice and the Pennsylvania Defense Institute

Dear Chief Justice Saylor:

We the undersigned organizations are writing to you in response to a letter sent to you by the Pennsylvania Association for Justice and the Pennsylvania Defense Institute (the Petitioners). It has come to our attention that your Court may be deciding this week whether pre-trial civil proceedings against healthcare practitioners and providers may continue during the COVID-19 pandemic. We would like to offer our stance on this matter and to request that this Court suspend all pre-trial proceedings against healthcare practitioners and providers, as well as other healthcare professionals (including administration and staff), for a period of 90 days or until the Governor lifts the emergency declaration for the COVID-19 response.

We understand that the judicial branch is a separate and equal branch of the government, and that irrespective of the disaster declaration issued by Gov. Wolf, the judicial branch may decide to continue civil litigation proceedings against health care practitioners. However, we would argue that this is a time when all branches of government must come together and recognize the new reality that we as a Commonwealth are facing.

Respectfully, the Petitioners refer to the tremendous economic pressures that trial lawyers are facing during this pandemic. With all due respect to them, the entire Commonwealth is facing economic pressures, and this fact should not serve as the impetus to allow civil litigation to continue as though we are not dealing with this horrific pandemic. We, as healthcare providers, are not immune to the economic pressures being felt, as many private practice offices are faced with the prospect of having to reduce staff or close their offices entirely and hospitals and healthsystems are





















canceling elective surgeries and making enormous investments to deal with the anticipated surge of COVID-19 patients.

As you are aware, the New Jersey Supreme Court has suspended, for approximately 30 days, depositions of, and all required appearances for, any doctors, nurses, or other healthcare professionals who are involved in the COVID-19 health emergency except for specific instances. New Jersey has recognized the need to allow healthcare professionals to focus on this pandemic for the near future and to not be distracted or have their time taken away by other matters such as pre-trial proceedings. We feel that 30 days is not enough time, and rather than revisiting this issue in one month, we are asking this court to consider a longer timeframe.

We are asking this Court to likewise suspend pre-trial proceedings for a time period, but not just for frontline practitioners. Those on the second line and beyond should be provided this reprieve as well. Even practitioners and providers not in areas largely affected by the Governor's closure order are indispensable at this time, as they also are dealing with medical supply shortages, layoffs, debt, trying to implement telehealth, and a myriad of other issues. Moreover, trying to parse out who is truly "involved" in this pandemic is not as simple as it sounds; all healthcare practitioners and providers are involved, whether directly or indirectly.

Healthcare in Pennsylvania needs to be focused on healthcare right now. Financial implications of law firms should not take precedence over this health crisis that we are all confronting. Practitioners are stressed, scared, being asked to perform in situations unimaginable, all while worrying about their own health and safety. At this time, practitioners should not be taking time away from caring for people to meet with lawyers, prepare for depositions, and be questioned about a case that is not at the forefront of their minds right now.

We are not minimizing any plaintiff's allegations against a practitioner or provider, nor are we seeking dismissal of any claims. We are simply asking that the Court recognize these unprecedented times and provide a temporary cessation of proceedings against practitioners and providers. The more practitioners can focus on this pandemic, the better the Commonwealth will be.

The Petitioners argue the constitutional provision that the courts shall be open. This Court has recognized that in these times, that provision is not black and white. The courts can still be open. Complaints and responses can be filed electronically, attorneys can still speak to each other about cases, and general motions practice can proceed. All sides need to recognize that business cannot continue as usual and it would be disappointing for the judiciary to not provide this short-term relief.
