Resolutions

What are we resolving to do in 2018? We resolve to do something, become involved, advocate for change, set policy, take action and more. As we increase the visibility of POMA within our membership, raise the profile of our leadership, position ourselves to represent the unique profession of osteopathic medicine, POMA needs to provide the osteopathic perspective on issues of relevance and importance.

Recent activities related to the Governor's declared state of emergency on the opioid crisis in the Commonwealth underscore the need for POMA to have a position on pain management and physician opioid prescribing. Hence, the following policy statement approved by POMA's presidential leadership (immediate past, present, and elect).

POMA Pain Management and Opioid Use Policy (01/2018)

The Pennsylvania Osteopathic Medical Association (POMA) understands the need to provide effective pain relief and encourages all health care providers to receive training on appropriate opioid prescribing, particularly for patients who suffer from acute and chronic pain.

Medical Marijuana Program

Pennsylvania's Medical Marijuana Act, (Act 16) originally signed into law in 2016 by Governor Tom Wolf, is on track to be implemented in early 2018

The program will provide access to medical marijuana for patients with a serious medical condition through a safe and effective method of delivery that balances patient need for access to the latest treatments with patient care and safety. Registration to participate in the program is open for physicians, patients and caregivers. Information on how to register as well as the link to the registry can be found at www.medicalmarijuana.pa.gov.

For any physician interested in participating in the Medical Marijuana Program, there are a number of steps that must first be completed in order to be approved as a practitioner who can issue patient certifications. These steps are outlined in a letter prepared by Dr. Rachel Levine, which answers some frequently asked questions and provides additional information. You can find the letter on the POMA website at www.poma.org.

As program implementation nears, the number of questions many physicians have regarding the program and signing up increases. Continue to check the Commonwealth's website for regular updates.

An Update from the SBOM – Dec. 13 Meeting

The Pennsylvania State Board of Osteopathic Medicine convened on December 13, 2017. Commissioner Harlow announced, due to legislative delay Drs. Frank Tursi (Erie, Pa.) and Christopher Poggi (Somerset, Pa.), were unable to be seated for the meeting. Dr. Burton Mark, Board Secretary presided. DO board attendees included Drs. Burton Mark (West Chester, Pa.), John Bulger (Danville, Pa.), William Swallow (Lewistown, Pa.), and Randy Litman (Lansdale, Pa.).

Cases reviewed by the board centered about both personal and professional use of potentially addictive substances. Board decisions emphasized:

- Development of institutional standard procedures for utilization of the Pennsylvania Drug Monitoring Program (PDMP) website for all care plans which involved controlled substance prescriptions;
- Adherence to prescribing recommendations (quantity and dose) for patients with acute need;
- Familiarity with documentation requirements for chronic utilization of controlled substances and the available opiate agonist/antagonist alternatives.

The last item on the agenda included the Commonwealth of Pennsylvania's requirement to elect a board chair and vice chair to serve the board during the cycle which begins in 2018. Drs. Randy Litman and William Swallow were elected to serve as Chair and Vice-Chair, respectively.

The next meeting of the SBOM is Wednesday, February 14 at 9:30 am in Harrisburg. Meetings are open to the public — physicians are encouraged to take advantage of this opportunity to participate in matters affecting the osteopathic profession in the Commonwealth.

The meeting began with an icebreaker game in which people were given an index card with a word on it. By asking questions to others they had to determine what the word was and then find the person who had a related word. Each pair then introduced each other to the group.



The Young Physician Leadership Forum to be held during the POMA Annual Clinical Assembly in May 2018 was discussed. There is great interest in this, and the idea of it being available online for those who cannot attend the live meeting. Proposed topics were Practice Management issues including direct primary care, discussions on billing, and medical legal issues including malpractice hints and how to avoid lawsuits. For the live meeting, Saturday afternoon still seems to be the preferred time. There was also interest for an auxiliary program.

Yvonne Hersh discussed the results of the Mental Health/Wellness Residency Program Grants and encouraged programs to apply this year. Up-



dates were also given by POMA CEO Diana Ewert and Joseph Zawisza, DO from the POMA Board of Trustees.

POMA is able to get osteopathic physicians to come to programs and teach OMM. Program directors can request this from POMA.

The position was previously held by Robert J. George, DO. Dr. George is retiring after 14 years with the College and will assume the role of Dean Emeritus.

Dr. Kauffman served as Associate Dean of Students, Enrollment Management and Graduate Studies at LECOM.

PCOM Expands in Georgia

The Philadelphia College of Osteopathic Medicine (PCOM) recently received initial approval from the AOA's Commission on Osteopathic College Accreditation to establish an additional location in Moultrie, Georgia. PCOM South Georgia will seek to recruit qualified students from Georgia and surrounding states who wish to pursue a career in rural medicine. PCOM will now move forward with the development the new four-year campus which will begin classes in August 2019.

Osteopathic physicians are uniquely qualified to provide non-pharmacologic alternatives to treat pain through the use of Osteopathic Manipulative Medicine (OMM) and POMA advises physicians to consider the safest appropriate treatment for patients. The routine prescription of opioids to treat pain has, in some cases, resulted in addiction, overdose and death.

POMA provides continuing medical education on proper opioid prescribing practices and management of acute and chronic pain, including the application of OMM.

POMA has long been a leader in providing education on the proper prescribing of opioids, including recent partnerships with the CO*RE REMS, a group whose mission is to "promote individual and population health and public safety through timely, evidence-based, outcome oriented and interprofessional education related to the comprehensive management of pain, addiction and their comorbidities." The curriculum helps clinicians balance the risks of opioid analgesics with the benefits for relief to patients. POMA has an opportunity for greater involvement in this state of emergency.

The POMA Committee on Legislation and Public Policy will be meeting shortly to discuss our positions on current legislation and where we are from a policy perspective. What resolutions should the committee consider in putting forward for approval through the governance process? What can we do to ultimately improve patient care? POMA must look at the needs and health conditions of Pennsylvanians and craft policy accordingly.

Let's start with a Resolution: THE ROLE OF THE PENNSYLVANIA OSTEOPATHIC MEDICAL ASSOCIATION (POMA)

WHEREAS, the Pennsylvania Osteopathic Medical Association (POMA) has a critical role to provide osteopathic physicians continuing medical education, advocacy, life-long learning and leadership to improve patient care; now therefore be it

RESOLVED, that POMA be recognized as a statewide leader and advocate for osteopathic physicians and their patients. This is our beginning!

Update on Pennsylvania Act 26 – Medical Records Copying

On February 18, 1998, Governor Ridge signed a measure reducing the costs of copies of medical documents in Pennsylvania. Act 26 of 1998, which became effective on April 19, 1998, regulates the cost of copying and postage charges for medical and hospital records. The Secretary of Health is directed to adjust these rates based on the most recent changes in the consumer price index, reported annually by the Bureau of Labor Statistics of the United States Department of Labor.

The listed fees shall apply for paper copies or reproductions on electronic media whether the records are stored on paper or in electronic format.

Effective January 1, 2018, charges for medical records may not exceed:

- \$22.48 for search and retrieval;
- \$1.51 per page for the first 20 pages;
- \$1.12 per page for pages 21 through 60;
- \$.38 per page for pages 61 and thereafter;
- \$2.23 per page for copies from microfilm;
- \$28.48 flat fee for copies to support claims or appeals under the Social Security Act or claims under other Federal or State financial needs based benefits programs; and
- \$22.48 flat fee for supplying records requested by a district attorney

The previously listed fees shall apply for paper copies or reproductions on electronic media whether the records are stored on paper or in electronic format.

In addition to the amounts listed previously, charges may also be assessed for the actual cost of postage, shipping and delivery of the requested records.

The previous charges, however, are subject to the following exceptions:

1. An insurer shall not be required to pay for copies of medical records required to validate medical services for which reimbursement is sought under an insurance contract, except as provided in: (a) the Workers' Compensation Act (77 P.S. §§ 1—1041.4 and 2501—2506) and the regulations promulgated thereunder; (b) 75 Pa.C.S. Chapter 17 (relating to Motor Vehicle Financial Responsibility Law) and the regulations promulgated thereunder; or (c) a contract between an insurer and any other party.

2. The charges listed in this notice do not apply to an X-ray film or any other portion of a medical record which is not susceptible to photostatic reproduction.

3. The charges for the production of medical records by a health care provider in response to a request made by either an individual who is the subject of the health information or the individual's personal representative is governed by the Health Insurance Portability and Accountability Act (HIPAA) and Federal regulations enacted under HIPAA, including 42 U.S.C.A. § 17935(e) and 45 CFR 164.524 (relating to access of individuals to protected health information), as follows:

a. Electronic health record. Under 42 U.S.C.A. § 17935(e), if a health care provider uses or maintains health records in an electronic format with respect to protected health information of an individual, the individual shall have a right to obtain from the health care provider a copy of the information in an electronic format. The individual also has a choice to direct the health care provider to transmit electronically a copy of the health record directly to an entity or person designated by the individual, provided that any choice is clear, conspicuous and specific. Any fee that the health care provider may impose for providing the information (or a summary or explanation of the information) in an electronic format shall not be greater than the labor costs

in responding to the request. The United States Department of Health and Human Services has stated that the labor costs may not include costs associated with searching for and retrieving the requested information.

b. Health record used or maintained in other types of format (for example, paper). Under 45 CFR 164.524(c)(4), if the individual requests a copy of the protected health information or agrees to a summary or explanation of the information, the covered entity may impose a reasonable, cost-based fee, provided that the fee includes only the cost of: (1) labor for copying the protected health information requested by the individual, whether in paper or electronic form; (2) supplies for creating the paper copy or electronic media if the individual requests that the electronic copy be provided on portable media; (3) postage, when the individual has requested the copy, or the summary or explanation, be mailed; and (4) preparing an explanation or summary of the protected health information, if the individual agrees in advance to a summary or explanation and the fees to be imposed, in accordance to 45 CFR 164.524(c)(2)(iii). Similarly, the labor costs under 45 CFR 164.524(c)(4) shall not include the cost attributable to search and retrieval of the records.
